## MISSOURI LEGISLATION DRAWS ATTENTION

A new statewide coalition has formed in Missouri to work for justice in immigration legislation. The Missouri Immigrant and Refugee Advocates, or MIRA, includes groups from St. Louis and Kansas City. On Monday, January 22 MIRA sponsored a briefing for thirty-seven legislators. The next day close to 100 volunteers came from Kansas City, St. Louis, Columbia, Jefferson City and Cape Girardeau to lobby for HCR 14 and SCR 6, an Anti-Discrimination Resolution (see text on p. 2) that was introduced by Senator Joan Bray and Representative John Bowman.

A press conference was well attended. Then as the volunteers were on their way home, Senators Chris Koster and Tim Green announced SB 348 which appears to be worse than a similar bill adopted in Colorado last year. SB348 creates the Missouri Omnibus Immigration Act.

Key points:

- It is illegal to employ unauthorized aliens. Every employer in the state is mandated to participate in the federal Basic Pilot Program to verify an employee's work authorization. Certificates of incorporation and other business licenses will be suspended for employing unauthorized aliens.

- It is illegal to rent any dwelling to an illegal alien, Rental licenses and occupancy permits will be denied or suspended for knowingly or recklessly renting. A process is created for verifying immigration status through the Division of Immigration Enforcement.

- Law enforcement officers must inquire into the immigration status of any individual detained for any violation unless the inquiry would significantly extend the duration of the detention. If illegal, the officer shall cooperate with any request from federal authorities regarding detention and custody transfer.

- The state shall enter into cooperative agreements with the federal government to designate state law enforcement officers to help enforce federal immigration law.

- Illegal aliens are barred from attending all public universities in the state and shall not receive any type of public assistance or benefit.

- The act also authorizes cities, villages, and towns to enact ordinance prohibiting the employment of unauthorized aliens or unlawful workers and may deny business licenses to employers who employ unlawful workers.

## House Concurrent Resolution No. 14: 94<sup>th</sup> General Assembly

**Whereas**, we affirm the inherent dignity of all people, regardless of color, religion, or immigration status, and we expect equality and justice for all; and

**Whereas**, hard working, tax paying immigrants embody our Missouri values of hard work, faith, and family and come to establish roots in Missouri communities in search of the American Dream; and

**Whereas**, we reject the extremism of anti-immigrant groups that seek to use fear to confuse and divide our communities; and

**Whereas**, we support the right of all Missourians to express their opinions about the best course for our

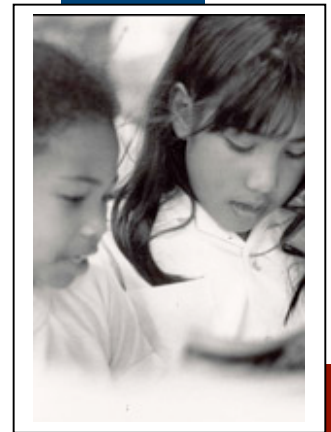
nation's immigration laws and commit ourselves to advancing a civil, respectful, and humane dialogue on the same; and

**Whereas**, we recognize the connections between many anti-immigrant groups and white nationalist organizations and disavow their message of racial hatred; and

**Whereas**, we acknowledge the proud history of our state and our nation as a country of immigrants and believe that immigrants continue to be an important part of our heritage and prosperity:

**Now, therefore, be it resolved** that the members of the Missouri House of Representatives, Ninety-Fourth General Assembly, First Regular Session, the Senate concurring therein, hereby call for a unified voice against anti-immigrant groups and their organized bigotry and dangerous vigilantism and continue working together in coalition with immigrant, labor, community, business, and religious groups to promote a welcoming Missouri and protecting the civil and human rights of Missouri's immigrant families while calling on Congress to address our nations' broken immigration system in a comprehensive fashion.

## Dispelling the Myths

- **Immigrants don't pay taxes:** they pay between \$90 and \$140 billion a year in federal, state, and local taxes. Also, the "suspend" file (taxes paid which don't match ss#) grew by \$20 billion between 1990 and 1998
- **Immigrants are a drain on the economy:** 70% arrive at prime working age, pay \$550 billion into the SS system, start their own businesses, The net benefit of immigration to the U.S. is nearly \$10 billion annually.
- **Immigrants take jobs from citizens:** the work force is getting older, fertility rates are lower...actually, we need workers.
- **Immigrants don't learn English:** within 10 years 75% speak English well.
- **Immigrants come to take welfare:** undocumented persons are not eligible for benefits and must wait five years if they have a green card; any help they might receive does not equal taxes paid.

### The Federal Solution: When Will It Come?

Insufficient legal avenues for immigrants to enter the U.S., compared with the number of jobs in need of workers, has significantly contributed to the current conundrum.

At the same time, we must realize that people

don't leave home unless they cannot stay. Studies are revealing that NAFTA and other free trade agreements have forced people to migrate. Wages have dropped 22%, prices for corn have fallen 70%, 81% of rural people live in poverty.

The Senate will probably present a new bill for immigration reform in February.
